The dimension requirements in the following table and the listed notes and exceptions to those requirements shall apply for all uses of land in those districts specifically stated otherwise is these regulations:

(1) Numbers are minimums required for any use of land on the lot. For example, two dwelling units on one lot in the RA-80 district would require a total of at least 160,000 square feet of lot area, not 80,000 square feet and three hundred (300) feet of frontage, not one hundred fifty (150) feet. Interior Lots require $150 \%$ of area for the underlying zone. Exceptions are that home occupations and outbuildings or structures accessory to a dwelling unit shall not require any area or frontage in addition to the minimums required for their related dwelling unit, nor
