Tyra then spoke about funds and that the AG commission has no funds of their own and that practice in the past was to go to the Economic Development Committee in principal they will support any thing that comes out of this. Vern thinks if we are gong to pursue this it sounds like we are going to repeat what was done years ago with a few additions to the list and as far as how the information is distributed we should look at adding electronical brochure along with paper. Tyra agreed that both electronical and paper is the way to go. Valerie question without knowing the funding amount what is the minimum we can do. Vern stated the minimum we could do is the electronic. Valerie then asked if we had access to this electronic version could we update the information we the information we solicited on the town web site. Tyra then pointed out we would be going back to where we started with FOIA. What Valerie was trying to get to is what level we could use to get this out without funding and improve when we get some sort of funding. The commission as a whole started looking at the old brochures to see who can be crossed out and who needs to be contacted like Jade Hill Farm and Wilsonville Herb Farm run by Gary and Marsha Kettle. All farms on the current brochure need to be updated except Siegmund Family Farm. Tyra suggested we contact Wilsonville Herb Farm as well as they sell other products from local businesses and they may want to be added to

the list. Vern suggested we look into other businesses that offer AG services. Valerie suggested Sunset Nurseries 860-923-3711. Randy also suggested veterinarian services, Animal Care Experts. Tyra let the commission know that whatever direction we wanted to go that if we need a help in writing a grant she would assist and as some point we will need to approach EDC. The list that was worked on we are going to split up and have each member contact the assigned businesses to see if they still want to be on the brochure. Tyra then suggested to add The Tree House at Underhill Hollow to contact. Valerie want to welcome Ryan to the meeting. Ryan also mentioned he has worked on grants before and he also spoke about the bio digester program.
