4.BOF discussion: proposed cover 2019-2020 Annual Report- the new town logo was favorably received by the BOF for the front cover of the Annual Report. 5. The Budget Workshop opened at 7:05 PM (page 39, Fire Departments) and concluded at 9:05 PM (page 51, Public Works). A regular meeting of the Fire Departments on this date was rescheduled in order for several of the Chiefs to be present; Chief John Sharpe (Community Fire District) provided background information and answered BOF questions. Animal Control Officer Janis Smith and DPW Director Rich Benoit each respectively addressed points brought up by BOF members or questions regarding their departments.

The BOF has requested further information: 1). Income generated by all departments, such as Transfer Station/Bulky Waste, Animal Control, Trails/Rec/EDC events, Fire Marshal and all others. This will assist the BOF in putting the budget requests in perspective. 2). Details about the fuel price negotiations by the Finance Director and the sources of fuel expense reimbursements from the schools and other departments. 3). A list of the "over-shots" from the current fy. NOTE: The Finance Director is flagging the budget pages which the BOF wants to review during the second budget examination. The recording Secretary is keeping a list of information requested throughout the budget review process; it will be forwarded to the BOF.
