

## THOMPSON Board of Finance Special Meeting/ Budget Workshop-Minutes Tuesday, April 13, 2021 via Zoom from remote locations

1. The call to order by Chair Aaron McGarry was at 7:03 with all BOF members present

Roll call: Members-Aaron McGarry (Chair), Jim Bellavance, Rob Mann, Rhonda Rooney, Robert Werge, Steve Herbert. Orla McKiernan-Raftery (Finance Director)., Rich Benoit (Director/DPW), First Selectman Amy St Onge, Selectmen Susanne Witkowski and Ken Beausoleil. Melinda Smith (Superintendent of Schools), Board & Commission members, Town Officials. Department heads. Members of the public. Recording Secretary Dotti Durst

3.Citizens' Comments- Three minutes per person maximum: Jess Bolte, 1081 Riverside Dr asked BOF members to attend the other Board/Commission meetings in order to better understand the budget proposals

- 4.Budget Workshop:
- \* Insurance rates will be lower than projected at about a 10% increase rather than 14%
- \* The tax collector expects partial income from Nutmeg Industries in FY 2022, the balance over 5 years
- \* The Finance Director prepared 5 scenarios, as requested by the BOF, demonstrating the impact on the Fund Balance/Debt should DPW vehicles under discussion be re-financed/purchased/leased-to-own
- \* M. Smith: the Schools' lockers sharp, corroded edges could be a safety issue, as could lifted floor tiles
- A. McGarry: accreditation will be reviewed in 2+ years; these need to be handled, keeping students safe
- \* The Fire Fighter tax abatement is currently at \$1,500 per person; the proposal reflects this amount
- \* Revaluation set-asides prepare for the five-year expense; there is currently no 5-year payment contract
- \* Chair A. McGarry confirmed: NDDH fees amount to a tax and is not negotiable (per Town Attorney)
- \* S. Witkowski reviewed BOS thinking about funding for Community Ambulance under Capital Improvement. Moving the 75K back into the Operating Budget will increase the budget
- \* Dog Fund assets which accumulated from town dog tag fees can be utilized by the BOF for dog care
- \* A. St Onge: the fees at the Transit District (NECCOG) may be flexible without a decrease in service
- \*At the close of this BOF meeting, the projected budget shows an increase of 0.83 mils or 3.4%

- impacts of the reduced Insurances rates on other staff including volunteers/fire fighters
- impact of reduction of costs of Hydrants; projected costs are down by \$5,000 (2202, 522221)
- (1201) Schools/Town split of new HR position: details of both Salary and Benefits (5100xx)
- possible penalties/fines if current debt for DPW vehicles is re-financed or the term shortened
- provide net savings if DPW vehicle re-financing/shortened terms are negotiated

Herbert to move \$75,000, Community Ambulance, from the Capital Improvement Plan (8101) to the Operating budget (2202), to be dispensed beginning July 1, 2021 in 12 equal increments over the 12-month fiscal year, providing that Community Ambulance continues to operate in the current manner; should that change, the remaining payments will cease.
