RESULTS OF ANNUAL TOWN MEETING – May 15, 2017

The Electors and Citizens qualified to vote in Town meetings of the Town of Thompson, Connecticut, are hereby notified and warned that the Annual Town Meeting of said Town will be held at the Thompson Public Library/Louis P. Faucher Community Center, 934 Riverside Drive, North Grosvenordale, Connecticut, on Monday, May 15, 2017 at 7:00 p.m. in the evening for the following purposes:

1. To choose a moderator for said meeting;
Motion was made by R. Morin to nominate Larry Groh, Jr. as moderator for meeting. The nomination was seconded by W. Witkowski. Motion passes.

Motion made by R. Morin to close nominations for moderator. The motion was seconded by J. Lindley. Motion passes.

2. To consider and act upon recommendations of the Board of Finance that appropriations be made for the fiscal year budget for the period beginning July 1, 2017 and ending June 30, 2018 in the amount of \$25,922,696.00, consisting of \$7,472,543.00 for the general government budget, and \$18,450,153.00 for the education budget, and to make such appropriations as are advisable in adopting a Town budget.

Discussion was held.

3. To consider and act upon the following resolution:

RESOLVED, that the Board of Selectmen, acting as agents for the Town of Thompson, be authorized to apply for and receive any state or federal grants that may become available and appear to them to be in the best interest of the Town of Thompson.

Motion was made by A. R. Trudeau and seconded by J. Lindley to approve resolution.
Motion passes.

4. To consider and act upon the following resolution:

RESOLVED, that the Town of Thompson's local capital improvement projects of \$162,242.00 and capital improvement plan as defined in Section 7-535 through 7-538, a copy of which plan is on file in the Office of the Board of Selectmen and available for public inspection during normal business hours, is hereby ratified and approved.

Motion made by S. Brissette and seconded by L. Jarmolowicz to approve resolution.
Motion passes.

5. Notice is further given, pursuant to the provisions of Section 7-7 of the Connecticut General Statutes; and the town budget resolution presented at Town Meeting on September 29, 1997 and approved at referendum on October 9, 1997, the Board of Selectmen has removed Item 2 (the budget) for submission to the voters in a manner provided by said statute. A machine vote will be held between the hours of 12:00 p.m. (noon) and 8:00 p.m. on Tuesday, May 23, 2017 at the regular polling places, and said Item 2 will be divided into separate votes on the general government budget and the education budget as required by the Town Budget Resolution.

District No. 1 — Thompson Hill Fire Department, 70 Chase Road, Thompson

District No. 2 — Town Office Building, 815 Riverside Drive, North Grosvenordale

District No. 3 — Quinebaug Fire Department, 720 Quinebaug Road, Quinebaug

District No. 4 — East Thompson Fire Department, 530 East Thompson Road, Thompson

Persons qualified to vote in town meetings who are not electors will vote at: Town Office Building, 815 Riverside Drive, North Grosvenordale. Absentee ballots will be available from the Town Clerk's office. Absentee ballots will be counted at the following central location: Babbitt Veterans Room, First Floor, Town Office Building, 815 Riverside Drive, North Grosvenordale. Action on said items at the Town Meeting will be limited to reasonable discussion only.
