Mr. Groh noted that the Annual Town Meeting was held on May 16, 2011. The Budget Referendum will be held on May 24, 2011 from Noon to 8 p.m. at the regular polling places. District 2 voting will take place in the Merrill Seney Community Room.

Mr. Groh stated that the Memorial Day Parade will be held on May 30, 2011. The Board will meet at 8:45 a.m. to prepare for the Parade at 9:00 p.m.

Mr. Beausoleil stated that there will be a Special Selectmen's Meeting on May 26, 2011 at 7 p.m. at the East Thompson Fire Station. This will be to address insurance issues, and will be followed by the Fire Advisory Committee Meeting.

Mr. Bell stated that the Iraqi Freedom Monument Ceremony was well done. He also inquired about the recent rail study for Thompson. Mr. Groh will check with the Town Planner on this. Mr. Bell noted that the Highway Department has been filling pot holes in town. Mr. Bell informed the citizens that after the Memorial Day Parade at 9 a.m., the VFW will be visiting several cemeteries to honor veterans, and will conclude their activities with a ceremony at the VFW Post, followed by a free meal at the Post at Noon.

CITIZENS' COMMENTS

Mr. Walsh commented on the low turn out at the Annual Town Meeting. There was a discussion of the impact of how the budget going automatically to referendum may inhibit citizen attendance at the Annual Town Meeting.

Mr. Landry stated that encouraging voter input earlier on in the budget process may contribute to earlier participation but not necessarily Annual Town Meeting attendance.

Mr. Walsh asked for the status of the Town website. Mr. Groh stated that work is progressing.

APPROVAL OF NEW HIRE – DANIEL PETRE – LIBRARY CUSTODIAN

Mr. Groh stated that Mr. James Rice will be greatly missed as the Library Custodian. He was a wonderful asset and committed employee. There were many applicants, with a wide range of skills, considered by the Hiring Committee. Mr. Beausoleil values the recommendation of the Hiring Committee.
