SELECTMEN'S MEETING **MINUTES** Tuesday, February 5, 2019 7:00 p.m. Thompson Town Hall - Seney Room \*

First Selectman K. Beausoleil called the meeting to order at 7 PM. The Pledge of Allegiance was recited

- II. Motion K. Beausoleil seconded by S. Herbert to approve the Minutes of January 15, 2019 carried with A. St Onge abstaining.
- III. Correspondence

- IV. Selectmen's Comments: S. Herbert –none

  - K. Beausoleil the NECCOG report on several matters under review is due out
  - congratulations to the N E Patriots
  - the state biannual bridge report was received/forwarded to the DPW Director for review
  - -the vacant industrial building at 720 Thompson Road has been sold to strong company already in the region; this will have a positive impact on the town
- Citizens' Comments: Wayne O'Brien, 108 Fabyan Road in the recent icy conditions V. during the cold snap, road salt was not applied to some roads, resulting in dangerous driving conditions. When the Highway Department was asked, they reported that the product does not function at temperatures lower than 12 degrees. He asked that the matter be examined from a public safety perspective.

- VI. Discussion with Town Attorney Ken Slater of some current matters of interest to the Board of Finance and the Board of Education as well as the Tourtellotte Board of Trustees, all of which have representatives present:
  - \*\* The easement for Buckley Hill Road is in process.
  - \*\* The Cold Spring property when the estate transferred to the beneficiary, two of the 3 parcels were so deeded. The intention of creating a Lifetime Interest in the parcel containing the spring to be retained by the owner, which upon his death would then be conveyed to the town, has imperfect language. It is being addressed.
  - \*\*65 Main Street, formerly used by TEEG, has a deed restriction, the terms of which are being examined carefully, in order to determine the most appropriate course of action which will remain within the expectations of the Tourtellotte Trust, requiring that the site be used to fulfill the stated Education-related goals. Attorney Slater detailed the process, which involves the Connecticut Attorney General's office, which is charged with evaluating any proposal, in terms of it being a close as possible to fulfilling the intention of the donor. The building is in poor condition, with lead paint and has no handicapped access, but it does have river frontage.

Executive Session adjourned at 9:01 PM I(no action taken); the Regular meeting resumed.

- VIII. School Security Update: applications have come in and been sent to the office of the Superintendent of Schools. Per the BOE request, while the position(s) will be funded by the town, and the Town will actually hire, the program will be implemented by the School District/BOE. Interviews will be conducted; the panel will include a wide variety of representatives of all involved offices including Schools Facilities Management and Town Emergency Management.
  - IX. Ordinance Discussion: Language has been drafted by the Town Attorney
    A. Bingo, Raffle shall Thompson move the fees for these permits out of the Ordinance and into a Fee Schedule, in order to eliminate re-writing the Ordinance if the fees change B. Town Budget this is under review. The break-points at which a Town Meeting is required for an anticipated expense, and the breakpoint at which it goes to referendum are being considered. If a vote fails, what process shall be used to move ahead? How this is organized in adjacent towns is being reviewed.
    - K. Beausoleil: If the oil tank question goes to referendum, these matters could be on the same ballot. However, a Town meeting can be called at any time.
  - X. Motion K. Beausoleil seconded by A. St Onge to appoint H. Charles Obert to the vacant seat at the Water Pollution Control Authority, through the current term expiring November, 2019, carried unanimously.
