- I. The Call to Order by First Selectman Amy St Onge was at 7:00 PM with all Selectmen present. Roll call: First Selectman Amy St Onge, Selectmen Ken Beausoleil, and Susanne Witkowski. Town staff members. Members of Boards and Commissions, and the public. Recording Secretary Dotti Durst

## IV. Correspondence:

- A. The First Selectman read aloud the January 2023 DESPP Police Services Report.
  -K. Beausoleil noted the frequency of out-of-compliance, and other vehicle-related situations on Buckley Hill Road and requests greater State Police attention to that area.
- V. Selectmen Comments:
  - K. Beausoleil: the lights in the park are still out. A. St Onge will follow up.
  - S. Witkowski: State Rep. Rick Hayes will be involved in the Quaddick State Park matter
  - A. St Onge \* The CT DEEP is working locally to draft a proposed ordinance regarding Quaddick Lake \* research is underway about a possible way to identify abandoned mill sites for inclusion in the possible ordinance. Riverside Drive work order for lighting is submitted \*Thompson Historical Society lease proposal has been reviewed and the process is moving along. \* the DPW budget is running favorably, there having been, so far, a minimum of salt needed and overtime. \*\* loss of power town-wide was significant, but the Fire Departments, DPW and Eversource worked diligently and power was fully restored within 24 hours. Emergency Services Director Steve Benoit added that there was, for the first time, a communications glitch. \* The Quinebaug Fire Department opened the emergency shelter —Thank you to them! \*The fees that will be assessed for the Stewardship of the former landfill on Pasay road have been reduced, with a key test not yet required but to be scheduled for a future date. \*The Budget Workshops began in February, with the major departments and the Fire Companies being scheduled for the next two weeks. Goal: by the end of February, the proposed budget will be finalized and presented to the public on March 2.

## VI. Citizen Comments:

- Valerie Clark, 105 Alm Road noted the recent very bad weather conditions, with Thompson among the towns with the greatest number of outages, yet the workers were able to fully restore power in 24 hours. She offered her Thank You to them.
- VII. MRFES PTO Request: Jessica Bolte was present to review the status of the playground.

  Motion S. Witkowski seconded by K. Beausoleil that the BOS approve the use of the

  Transfer Station by the elementary school PTO for the "Fill The Swing" event on March 11

  & 25, 2023 carried unanimously.
