- Mr. Groh presented correspondence from Premiere Labs in regard to well testing results.

- Mr. Groh presented correspondence in regard to health care issues and possible solutions.

SELECTMEN'S COMMENTS

- Mr. Groh informed the public that the Thompson Probate Court has changed its hours to comply with Probate Court Administration. The Court is no longer open on Saturdays and after 5:00 p.m. on Thursdays.
- Mr. Groh stated that he received a request from Don Brown in regard to the local Police Athletic League chapter. Mr. Groh explained that Mr. Brown explained that the form is a part of the renewal package for the PAL. Mr. Brown stated that they use the PAL to form the football team for Thompson and Ellis Tech.
- Mr. Groh informed the Board that there was an award put in for a Town employee for years
 of service. Mr. Groh stated the Joseph Arthur Girard has worked for the Town of Thompson
 for over 35 years.
- Mr. Groh stated that the proposed budget is now on the front page of the website for easier access.
- Mr. Groh stated that the budget resolution has passed at the Town Meeting on March 12, 2008.
- Mr. Groh announced that on Friday, March 31, 2008, the Town Hall, Highway Garage and Transfer Station will be closed in observance of Good Friday.
- Mr. Groh announced that for the past two Thursdays the proposed budget was presented to the Board of Finance and the public.
- Mr. Groh said that he attended a seminar in East Hartford on hiring practices.
- Mr. Groh asked Miss White if there is an Economic Development Commission meeting tomorrow night. Miss White stated that there is.

CITIZENS COMMENTS

- Mr. Brown asked if there has been any further action on the part of the Board in regard to the proposed regional recreation center. Mr. Groh said that there has been no discussion at NECCOG in regard to the center.
- Mr. Brown asked if there was going to be anymore discussion on the budget by the Board of Selectmen. Mr. Groh explained that the budget is now at the Board of Finance for review.
 Mr. Brown informed the Board that the Recreation Department is doing over \$300,000.00 in programs in a separate checking account that has no accountability for.

- Mr. Landry stated that the Norwich Bulletin endorsed the Regional Recreation Center and that there was mention that they are partnering with the Y.
- Mr. Elmes asked if the groundwater report relates to anything on Thompson Hill. Mr. Elmes asked if the Board knows where the Thompson Hill issues stands.
- Mr. Smith asked if there is a snowplowing and sanding policy. Mr. Smith stated that the Town truck plowed only half the road. Mr. Smith submitted a written letter to the Board in regard to this issue. Miss White requested that the First Selectman investigate this issue and report on it at the next Selectmen's meeting. A brief discussion followed.
- Mr. Landry asked if Mr. Smith meant only one side of the road or if the plow went down half the road and turned around. Mr. Smith stated that it was only one side of the road.
- Ms. Landry stated that the Community Art Show is opening on March 31, 2008 and it will be
 at the Thompson Public Library/ Community Center and the theme is "Trails and Pathways."
 Ms. Landry stated that this event will kick off the April Clean-up.

STREET LIGHT REQUESTS

Mr. Groh presented information to the Board in regard to two requests for new street lights at 227 Riverside Drive and 1145 Riverside Drive. Mr. Groh also presented information on the cost associated with the streetlights including installation and operation. Miss White stated the it would be useful to have an inventory of all of the lights and what is the average cost per light pole. A brief discussion followed.

Ms. Hiatt stated that she drove by the upper part of Riverside Drive and there appears to be sufficient light. Ms. Hiatt stated that she did not view the Mechanicsville School at night. A brief discussion followed.

Miss White stated that if the Board is going to pursue this, then the people requesting the lights should appear before the Board to make their case. Mr. Elmes suggested calling the electric company to get an inventory of the lights in Town. A lengthy discussion followed.
