**I.** The call to order by First Selectman Amy St Onge was at 7:00 PM.

K. Beausoleil \* The State is edging Rt 12/131, which is outside the sidewalk project zone A. St Onge \* Quaddick Rd work is underway, with some closures.. \* Covid CARES & American Rescue Plan funds are being reviewed by the Finance Director, the Town Planner and the First Selectman, for long-term planning. \* Interconnection with the Schools IT Department, the combining of Internet services including Security and possibly telephone services, has resulted in significant savings along with improved technology; Marie Mongeau (Selectmen's Executive Assistant) compiled spreadsheets.

Thompson Public Library – Daytime custodian proposed wage increase: it was noted that no representative of the Library Board of Trustees was present to assist with understanding how the work of the position in question was increased during the Covid period, noting that there was no evening custodian on staff. *All* town workers were dedicated during that time span. The BOS agreed that if the matter is to be pursued, it should go directly to the BOF. No action will be taken on the matter.
