- 5. Officer and Committee Report
 - <u>Round-Up Spraying</u>: Marla Butts has written to the Selectman requesting a policy to address the use of Round-up by the public works for next year. Marla Butts requested the policy should have the following: established areas that need treatment; avoiding inland wetlands, homes and recreation areas; announcement of town webpage on the areas and dates of treatment; process for requesting alternatives and process for address complaints.
 - <u>Gravestone Girls</u>: Brenda was here for a recreation commission summer camp program on the 2nd. The new brochures were distributed during this presentation. Norma O'Leary and Dan Malo are trying to establish an ongoing maintenance program to keep the cemetery's maintained.
 - North Grosvenordale Burial Site: In 2016, Norma O'Leary spoke with the state archaeology regarding this location. His response was based upon pictures supplied this is a burial site and should be treated as such. The developer is ready to get moving on developing the area with having the site memorialized. Dan Malo provided the town's GIS screen of the area. The developer will be putting in 2-3 homes. There is a conservations easement. There will be a site walk scheduled.
 - <u>Ordinance</u>: There is a meeting scheduled for Wednesday August 30th to discuss two ordinances that are being proposed. One ordnance is amending the flood prevention ordinance and the second is regarding vacant, abandoned, and tax delinquent properties.

- <u>Little River Watershed Plan</u>: The little river supplies water to towns and has agriculture in the areas. This little river watershed only has a small portion in Thompson. The plan will enhance the quality of the water. There is a meeting scheduled Thursday to discuss the plan.
- <u>Business/Volunteer of the year</u>: The town is accepting nominations through September 11th.
- <u>UCONN Presentations</u>: Dan Malo has been asked to speak at UCONN based on his experience with being wetlands and conservation agents.
- <u>Food Forest Project</u>: This is put on by the conservation district project. There is a community garden behind the new TEEG property. It is suggested that a food forest would be in the same area. There is no access to the river at this location. The committee meets monthly, the next meeting is in September.
- <u>Wetlands Agent</u>: Marla Butts is reducing her hours at the office. Dan Malo will work to cover some of her duties. During this transition and consolidation of positions in Thompson, Dan will continue to be the Wetland Agent for Woodstock until they find a replacement.
