Officer and Committee Reports

1. Conservation Officer Report
 - a. New Requests: None
 - b. Old Requests: None
 - c. It was noted that a technical error was made for voting to place an Executive Session item on the April agenda prior to voting to go into Executive Session.
 - d. The Commission is still waiting for a written response or comment from Attorney St. Onge on the liability of volunteers assisting with cemetery maintenance. The item will be pursued with First Selectman Paul Lenky.
 - e. The Conservation Commission Ordinance language has been resolved by Town Counsel. The document has been prepared for the selectman to bring to Town Meeting.
 - f. The meeting of Bernie Davis, Phil Thomas and Carolyn Werge with First Selectman Paul Lenky for the Conservation Website has been scheduled for May 21 at 11:30am.
 - g. Allan Rawson has contacted Carolyn Werge about his proposed land donation and conservation easement in East Thompson. Carolyn Werge indicated they need to review the easement area with Mr. Messier.
 - h. Cemeteries Project
 - i. Poor Farm Cemetery: Carolyn Werge drafted a narrative and scanned relevant documents to be posted after they have been reviewed. Lynn Landry's father recalls permission being given in the 1930's for a garden to be created within the cemetery and removal of several stones.
 - ii. Junia Joslin Cemetery: State Archaeologist Nick Bellantoni and his crew visited the site on May 19 with the several Conservation Commission members. The findings were inconclusive as the site is overgrown and the ground penetrating equipment unusable. His recommendation is to consider it a cemetery and treat it as such.
 - iii. Whittemore Cemetery: Norma O'Leary reports the stone wall and clearing is almost complete.
 - i. The mapping software linked to the Assessors Database has been updated with 2012 aerial photos. Updates to cover changes from 2008 to present are necessary. Carolyn Werge will first discuss this with the selectman.

Ron Tillen moved and Bernie Davis seconded the motion to authorize the Conservation Commission spending of \$400-\$450 towards updating the mapping software changes from 2008 to present.

- j. Carolyn Werge reports the mapping request for the First Selectman of all town owned parcels is half done.
- k. Sue Vincent from the Historical Society has requested an aerial map to overlay a mylar map from the survey on top.
- l. The Trails Committee has been looking for a canoe launch on the French River off of Wilsonville Road. This location was found unsuitable. First Selectman Lenky proposed a site off of Riverside Drive. The Conservation Commission would like to carry out a site walk.
