  - a. McClure's Tech. is a new business in town located at 1 Quaddick Town Farm Road in Thompson, CT. The owner of this business is George McClure and the purpose of the business is to offer pc repair and maintenance.

***Citizens' comments pertaining to Agenda Items***

1. First Selectmen Paul Lenky attended the meeting and briefly updated the members of the Economic Development Commission on the Industrial Park on Reardon Road. Mr. Lenky stated that work there is progressing and that they have been working with the rail road to prepare the land. Mr. Lenky also noted that 3 phase power will also be an important part of the process and that it will run from Route 12 to the Industrial Park on Reardon Road. He also stated that a grant will be needed as part of the process but that ultimately the whole process will be very beneficial to the town of Thompson.
