The Electors and Citizens qualified to vote in Town meetings of the Town of Thompson, Connecticut, are hereby notified and warned that the Annual Town Meeting of said Town will be held at the Thompson Public Library/Louis P. Faucher Community Center, 934 Riverside Drive, North Grosvenordale, Connecticut, on Tuesday, May 30, 2023 at 7:00 p.m. for the following purpose:

1. To choose a moderator for said meeting;
2. To consider and act upon recommendations of the Board of Finance that appropriations be made for the fiscal year budget for the period beginning July 1, 2023 and ending June 30, 2024 in the amount of \$29,359,214 and to make such appropriations as are advisable in adopting a Town budget.
3. To consider and act upon the following resolution:  
RESOLVED, to adopt the Recodification and Technical Amendments of the Code of Ordinances
4. Notice is further given, pursuant to the provisions of Section 7-7 of the Connecticut General Statutes; and the Town budget resolution presented at the Town Meeting on September 29, 1997 and approved at referendum on October 9, 1997, the Board of Selectmen has removed Item 2 (approval of the Fiscal Year 2023-2024 budget) for submission to voters to vote upon paper ballots on Tuesday, June 13, 2023 between the hours of 12:00 p.m. (noon) and 8:00 p.m. at the following regular polling places:

District No. 1 — Thompson Library/Community Center, 934 Riverside Drive, North Grosvenordale

District No. 2 — Town Office Building, 815 Riverside Drive, North Grosvenordale

District No. 3 — Quinebaug Fire Department, 720 Quinebaug Road, Quinebaug

District No. 4 — East Thompson Fire Department, 530 East Thompson Road, Thompson

Persons qualified to vote in Town meetings who are not electors will vote at the Town Office Building, 815 Riverside Drive, North Grosvenordale. Absentee ballots will be available from the Town Clerk's office at Town Hall. Absentee ballots will be counted at the following central location: Conference Room, Second Floor, Town Office Building, 815 Riverside Drive, North Grosvenordale. Action on said items at the Town Meeting will be limited to reasonable discussion only.
