INLAND WETLANDS COMMISSION

TUESDAY, JULY 14, 2015 7:00 PM

MERRILL SENEY COMMUNITY ROOM - TOWN HALL

Due to insufficient membership the commission was unable to render any votes but still held a meeting.

Meeting was opened by Vice Chair Peter Ricard at 7:12 PM.

Roll Call: Commissioner and Vice Chair Peter Ricard, Commissioner H. Charles Obert Wetlands Agent Marla Butts and Recording Secretary Diane Minarik.

Absent: Commissioner and Chair Fran Morano, Commissioner Jarrett Thomas, Commissioner Donald Hoenig II and Commissioner Ron Tillen.

Budget & Expenditures: Wetlands Budget for Fiscal Year 2014 - 2015 (Results of Fiscal Reporting 7/1/14 - 6/30/15) Commissioner Obert stated that the Commission has used 99.5% overall of its budget.

Wetlands Agent Report -

Updates:

- **Computer and Network Issues** - A LaserJet Pro color printer was purchased last month and installed along with 2 gigabytes of memory for the wetlands office computer and \$378.75 was encumbered for Thompson webpage modifications.
- **Interstate Reliability Project Construction Update** - Most of the work associated with the project has been completed.

Inspections/Follow-Up Actions - None

Wetlands Agent Approvals Finalized - **WAA15015** and **WAA15016** received in the last couple of days are pending review.

Building Permits Reviewed:

Miscellaneous:

- **DEEP Training for Commissioners/Agents** - On July 1, Commissioner Obert and Ms. Butts attended the DEEP Municipal Inland Wetlands Agency Continuing Education workshop on legal and administrative updates.
- **Applied Graphics MapGeo Digitizing Subdivision Maps** - The expenditure of the encumbered \$400 is awaiting the receipt of an invoice from Applied Graphics to the Planning and Development Office.
- **Rotting Fence at Little Pond Beach Area** - Ms. Butts received an inquiry from Peter Nalewajk precedent of the Little Pond Improvement Association regarding a rotting chain-link fence that extends into Little Pond north of the beach area on Center Street. His concern is that the fence was rusting out and pieces were breaking off into the water which he thought would not be good for the lake or people.
- **Planning Regulations & IWC Signature Block on Mylars** - Ms. Butts suggested the IWC move to request the Planning and Zoning Commission change the word "endorsed" to "approved" when they next revise their subdivision regulations.


Purchase Requisitions Status:

- Paid \$577.39 for misc. expenses and encumbered \$1,078.75.

Commissioner Obert requested business cards or photo IDs for the commissioners.
