1. Call to Order & Roll Call.

Special Meeting was called to order by Chair Fran Morano at 7:03 PM.

Roll Call: Commissioner and Chair Fran Morano, Commissioner and Vice Chair Peter Ricard, Commissioner H. Charles Obert, Commissioner Jarrett Thomas, Wetlands Agent Marla Butts and Recording Secretary Diane Minarik.

Others Present: Bob Deluca of CLA Engineers, Lewis Worley and Stephen Herbert.

2. **IWA15012** Lewis E. Worley, 167 Fabyan Rd, Assessors Map 21, Block 84, Lot 15A&B, clean pond of accumulated sediment, stamped received by Wetlands Office on 6/1/15, statutory receipt date 6/9/15. Mr. Worley was present to answer any questions and he is ready to start tomorrow.

Motion to approve IWA15012 was made by Commissioner Obert. Seconded by Commissioner Ricard. Motion passed unanimously.

3. **#10-07-01** Tri-State Baptist Church, 386 Quinebaug Rd, Assessor's Map 38, Block 97, Lot 2-1, (1) request to extend permit for 5 years to 8/10/20 and (2) request to modify the detention basin outlet structure from a precast level spreader to a rip rap level spreader, stamped received by Wetlands Office on 7/1/15. Ms. Butts explained why they are requesting an extension of and a modification to the permit.

Motion to approve an extension of 5 years and the modification of #10-07-01 as requested was made by Commissioner Obert. Seconded by Commissioner Ricard. Motion passed unanimously.

4. **IWA13018** Town of Thompson, Marianapolis Sewer Line Extension, Assessor's Map 105, Block 38, Lot 1, permit modification request to change the method of construction of the Marianapolis Prep School sewer extension at the intersection of Route 12 and the I-395 southbound on-ramp between stations 4+50 to 6+90 from horizontal drilling to open trenching, stamped received by Wetlands Office on 7/6/15. Bob Deluca was present to explain why a modification is needed and to bring the commission up to date on project.

Motion to grant modification to IWC13018 as requested on documents submitted 7/6/15 with understanding of a 3 week differential was made by Commissioner Ricard. Seconded by Commissioner Thomas. Motion passed unanimously.
