a) Call to Order & Roll Call.

Special Meeting was called to order by Chair Ricard at 7:03 PM

b) Public hearing was reconvened by Chair Ricard to consider Permit Application #IWA15029 by River Junction Estates, LLC, Starr Road, construction of water diversions on Starr Rd, Assessor's Map 154, Block 3, Lot NA.

Due to a lack of quorum at 9:00 pm tonight the Attorneys were asked if they could limit their testimony to 30 minutes each to give citizens a chance to speak and be able to end this public hearing tonight. Atty. Penny said he would be cooperative in limiting his time if public comment time was very limited. Atty. Slater said he wanted to postpone the hearing to another date because his testimony will take longer than 30 minutes and he didn't want Commissioner Tillen to miss anything. After Mr. Rawson granted an extension to 6/22/16 and a discussion between Commissioners and Attorneys, Chair Ricard decided to use the remaining time this evening to hear citizen's comments.


