1. CALL TO ORDER

Chairman Blanchette called the meeting to order at 9:00AM.

- 2. APPROVAL OF MINUTES
 - a. October 13, 2017 Regular Meeting

- 5. COMMITTEE BUSINESS
 - a. Approve 2018 Meeting Schedule

(M/S/C Hall/O'Leary) to approve as presented. Carried unanimously.

b. 630 Riverside Dr. - Status Update

M. A. Chinatti stated she has heard nothing from S. Donohoe re how the owner intends to market the property though she has reached out to him a number of times.

Chairman Blanchette indicated she would email S. Donohoe for an update a week prior to the December meeting if nothing is provided before then.

c. 929 Riverside Dr. - Status Update

Chairman Blanchette distributed an emailed update from Sean Kellarson, CME. She reminded members that the Town authorized CME to resume their brownfield work last month, that Eagle was working on the HAZMAT survey and CME was working on the Phase II/III ESA.

- M. A. Chinatti stated there has been no update from J. Gumpert, Camden Partners, re execution of a contract between him and M. Harmon, Riverside Acquisitions. She stated she left J. Gumpert a voicemail yesterday but has not heard back.
- K. Beausoleil stated that J. Gumpert flew up recently with a potential investor to tour the mill/surrounding area, and J. Gumpert assured him that the project will happen "sooner rather than later."
- K. Beausoleil also noted that 910 Riverside Drive (aka the Pallet Co.) deed is expected to be filed January 5 or 7 of next year. He noted that the property was sold at tax sale and that the (potential) new owner has not elaborated on any plans he has for the building but to say he would be working on making any necessary repairs to the roof, etc.
- K. Beausoleil also stated, re 962 Riverside Drive (aka Quinn's Shirt Shop), that final revised plans have not yet been completed to incorporate recent code changes but they should be done soon.
