- 1. The call to order by Chair Steve Bordua was at 7:21, following interviews for Planner

- 3. Minutes review: February 27, 2019: no meeting was held Minutes March 5, 2019: **Motion K. Prescott seconded by C. Antos to approve with adjustments carried unanimously.** Abstaining were D, Godzik and R. Monahan. The spelling of Poirier, The Worcester Railers and a typo were noted.

Clarification: some programs in the summer occur in 2 fiscal years, one ending June 30, the other beginning July. For total numbers, both financial reports have to be consulted. The budget submitted to the BOS (2019-2020) for approval was with no changes to the current year budget.

- The current year budget seems to be on track as expected
- 5. Interim Director's report; a written report was distributed: key points
- comments have come in about the combined expenses rolled into the Summer Camp fees, eliminating the extra charge for field trips; most have been favorable.
- a Senior lunch with music is planned, with Rec to support decorations and dessert
- a letter of support has been drafted regarding a grant possibility for upgrading all the Thompson signage, making them unified and along a single theme.
- the Farm Passport program will take place, beginning in May
- band concerts and movies in the park will take place in Riverside Park
- 6. Update: Camp Subcommittee
 - EASTCON will provide an additional 3-4 staff members for Summer Camp
 - Summer Camp Bus transportation bids (2) will go to the BOS 04/02; STA = no bid.
 - Members of the public understand that when the DATTCO bus contract was signed for the school system, Thompson no longer owned buses that could be used for town programs. This has had a powerful impact on Summer Camp prices.
