

Recreation Commission Special Meeting Minutes
July 29, 2021, 6:30 p.m. via zoom

New Business:



Renee, Cindy & Wayne spoke in regards to recommending Brian Lievense for the position of Recreation Director of the Thompson Recreation Department. After interviewing a good pool applicants, the search committee, unanimously agreed to recommend Mr. Lievense to the Recreation Commission. There were ten applications, two were not at all professional, two indicated no relevant experience or experience, one declined an interview leaving five applicants who interviewed. Wayne Barber made a motion seconded by Robbie L'heureux to recommend the following to the Board of Selectmen:

Mr. Brian Lievense be hired for Recreation Director at the budgeted salary of \$53,300 and after a ninety day probation period the salary be increased to \$58,500
