APPLICANT'S INSTRUCTIONS FOR OBTAINING A PISTOL PERMIT

- 1. Complete the following paperwork:
 - A. <u>Pistol Permit Application:</u> Form DPS-799-C Complete Pages 1 thru 4 and have the Application notarized. A Notary Public is available in the Town Clerk's Office. There is no fee for this service. Note: Do not sign the Application in advance it must be signed in the presence of the Notary.
 - B. Applicant's Contact Information: Your telephone or e-mail information.
 - C. <u>FBI Privacy Statement and Signed Noncriminal Justice Privacy Rights</u>: Sign both forms.
- 2. Bring the above forms (A, B, C) to the Selectmen's Office, plus the following:
 - a) Your Birth Certificate if you are a native-born U.S. citizen or a U.S. Passport or a copy of your Naturalization papers.
 - b) Your NRA Gun Safety Course Certificate
 - c) Your valid Drivers' License.
 - d) Your DD-214 if you were ever a member of the Armed Forces of the United States.
 - e) Fee: A check or money order in the amount of \$70.00 payable to the Town of Thompson.

Paperwork must be submitted in person by each applicant.

- 3. Once we receive your complete application, we will give you the information you need for the next step registering on-line with the state and having your fingerprints taken.
- 4. We then wait for the State and FBI to process your application. Once we receive your fingerprint investigation results we will contact you and schedule an appointment for you to meet with the First Selectman for your Temporary 60 Day Pistol Permit. You'll receive then instructions on the final step getting your State of CT Permit to Carry Pistols and Revolvers.

 Upon approval, the local authority will issue a Temporary State Permit to Carry Pistols and Revolvers (DPS-11-C), effective for 60 days. 		
4. Within the 60 day period, go to a DESPP, Division of State Police, pistol permit location and submit the following:		
 The Temporary State Permit to Carry Pistols and Revolvers (DPS-11-C) issued by the local authority; A completed Application for State Permit to Carry Pistols and Revolvers (DPS-46-C); \$70.00 fee, payable to Treasurer, State of Connecticut; Proof you are legally and lawfully in the United States (e.g., certified copy of birth certificate, U.S. passport or documentation issued by I.C.E.); and Proof of valid state issued photo identification card. 		
5. Upon approval, your photograph will be taken at DESPP and you will be issued a state pistol permit.

As an applicant who is the subject of a national fingerprint-based criminal history record check for a noncriminal justice purpose (such as an application for employment or a license, an immigration or naturalization matter, security clearance, or adoption), you have certain rights which are discussed below. **All notices must be provided to you in writing.** ¹ These obligations are pursuant to the Privacy Act of 1974, Title 5, United States Code (U.S.C.) Section 552a, and Title 28 Code of Federal Regulations (CFR), 50.12, among other authorities.

- You must be provided an adequate written FBI Privacy Act Statement (dated 2013 or later), by the agency that will receive your criminal history results, when you submit your fingerprints and associated personal information.
