Meeting was called to order at 7:05 p.m. Lucille volunteered to moderate. Charlie made a MOTION, seconded by John, to accept minutes of December 7, 2020 and January 11, 2021. All in favor.

# Train Wreck site park project:

- Stephanie introduced Mallory Zink, new NPS historian that will be tasked to help with efforts around signage and interpretation for the train wreck site
- Stephanie asked Committee who could offer input on enlisting local youth with the next phase of community engagement; Lesley & John will offer ideas
- Joshua Conner reported the UCONN group's semester work started about 2 weeks ago; begins with written reports, then schematics on the parking area in March/April; semester ends in early May
- 1:00 NPS call with Tyra scheduled for 2/2

#### Trailer:

- Registration & Insurance: Trailer would be registered by the Town, so there is no registration fee; Selectmen decided the Town will cover the annual insurance, since it is under the Town policy. Since it will purchased through the town, there will be no sales tax.
- John shared revised quote from Hazard Marine of \$6,104.50 for a special order (special order required for 7 foot height.) Diamond Cargo Mfg 7x16 enclosed trailer for transportation and storage of Kubota and tools. Price now includes orange exterior paint, .030 gauge exterior skin, rear stabilizer jacks for loading, four D-rings for interior tie-down, spare tire & carrier.

Charlie made a MOTION, seconded by Lucille, to purchase the described enclosed trailer. All in favor. Predicted delivery 10-12 weeks. John will request an invoice and find out how much down payment is needed.

- Airbrush Shack offered to make decals of logos.
- Discussion about mower attachment.
- Continue discussion on crowdfunding at April meeting. Lesley and Brian will draft thank you letters to past sponsors of Turkey Trot and emphasize how their support enables equipment purchases to maintain trails.

## Trail updates:

• John has materials to re-blaze the Tri State Marker Trail with more permanent blazes. Paul volunteered to help with cutter & punch. Discussion of the North Grosvenordale River Walk extension along N. Grosvenordale Pond that needs blazing and how that should fit into downtown wayfinding signage.

- John reported on boulders and "no trespass" signs blocking a spur trail off the Tri State Marker Trail that is probably on town land. A **site walk** is needed to confirm boundaries with recently purchased properties.
- Increased trail use and **limited parking space** at Sand Dam Rd ALT access is creating **safety issues**. Moving rocks back, & adding fill, to enlarge parking area will keep cars & hikers out of roadway.
- \*ACTION ITEM: submit requests by 2/15/21 to Lesley for DPW spring work, to compile for Kelley, to bring to Rich and Selectmen
- other issues include ATV abuse, parking at Lowell Davis access point, stone dust erosion between Lowell Davis & 395 overpass, unleashed dog

- Paul is refilling Train Wreck flyers every week; has about 50 left. Asks if we can print a black & white map? Charlie & Lesley will look at how to reduce artwork on ALT color brochure to 8.5 x 11" size for next printing. Charlie has edits to text first.
